Rules for the Maison des Jeunes Sutton

1. Use a polite and respectful language.
2. Respect the Maison des Jeunes' environment as well as the people who find themselves there.
3. Resolve your conflicts with methods other than by using verbal, psychological or physical violence.
4. Come to the Maison des Jeunes without being under the influence of alcohol or drugs.
5. I respect those that are playing (pool, baby foot, Mississippi, on computers, etc.,) and the order of the players. I respect those around the playing area even if they are not participating.
6. If I am part of a couple (dating, relationship), I will be respectful of others by being discreet in my romantic exchanges with my partner.
7. When consuming food/snacks (meals, drinks, candy, snacks, etc,) I will dispose of my garbage in the appropriate containers, clean up my mess and wash my dishes etc, (if applicable)
8. I will help keep the Maison des Jeunes clean inside as well as the outside. I will assist in the clean up.
9. Wrestling, weapons, throwing objects, "play fighting" and/or fighting are forbidden. No tossing or launching objects.
10. Do not commit any illegal actions at the Maison des Jeunes or on the surrounding grounds. The Maison des Jeunes is there for you so take care of it!
11. Finally, we trust you on your capacity to judge for yourself what is right or wrong and to act accordingly.
12. Expect to undergo the consequences of your actions if you do not respect the Maison des Jeunes' rules.


